Sealed with our seals, and dated the 11th day of July A. D. one thousand eight hundred and forty 54

The Condition of the above Obligation is such, That if there be no lawful cause why Charles M Prodwater and Bunnetta B Gray should not be joined together in the holy union of Matrimony, then this obligation to be void; else to remain in full force and virtue.
