In the family graveyard, on land now owned by descendants, all tombs are there, but no markers. It may have been the site of a Civil War battle, and thus they were destroyed.

Matthew Gayle was born September 21, 1801 in Sumpter District, S. C. He died April 30, 1862 at East Feliciana, La. He married Dec. 2, 1822, at St. Helena Parish, La., Elizabeth Bell, b. Aug. 2, 1801, East Feliciana, La., d. September 24, 1837. She was the daughter of William Bell. Matthew Gayle was a farmer and overseer and a member of the Episcopal Church. He married (2) Harriet Irving, Feb. 4, 1839, West Feliciana Parish. No children by second marriage.

He was the son of Little Berry Thompson and his wife Patience.
