

- GEE, Capt. John - land purchased recorded in Davidson Co. (see p. 41).
- GERRARD, Charles - land purchased recorded in Davidson Co. (see p. 42).
- GIBSON, "Old man" - killed by Indians in 1786/87: [ref. 4].
- GIBSON, Jordan (variously, Jourdan) - purchased a bed from Jas. McCane (sic), according to a deposition taken before the Committee of the Cumberland Association, Jan. 18, 1783: [ref. 5a]. 1787 Sumner Co. tax roll with 2 polls & 320 acres: [ref. 5b]. On the motion of James Harrison, James Odom, & George Gibson, the Sumner Co. Court in 1788, ordered Anthony and Isaac Bledsoe and George Winchester to "divide the personal estate of the late Jourdan Gibson and divide it into four equal parts: [ref. 5c]. (See also, p. 42.)
- GIBSON, Roger - juror during the Oct. 1789 Session of Court: [ref. 6a]. Bondsman for marriage of John Neiley and Mary Harrison, Apr. 1791: [ref. 6b].
- GIBSON, W. - early settler at Bledsoe's Lick (see p. 43).
- GILBERT, Alia - was married in Sumner Co., Nov. 16, 1791, to Thomas Payton: [ref. 7].
- GILBERT, Samuel - bondsman for marriage of Alia Gilbert to Thomas Payton: [ref. 8].
- GILBREATH, Arthur - of Hawkins Co., North Carolina, executed Power of Attorney, Nov. 18, 1789, to Thomas Sharp to recover notes from James McKain: [ref. 9].
- GILLESPIE (variously, GILLESPIE), George - land purchase recorded in Davidson Co. (see p. 43).
- GLASGOW, Cornelius - was listed on the 1787 Sumner Co. tax roll with 1 poll: [ref. 10].
- GLASGOW, James - land purchase recorded in Davidson Co. (see p. 43).
- GODFREY, William - land purchase recorded in Davidson Co. (see p. 44).
- GOODWIN, Nathan - land purchase recorded in Davidson Co. (see p. 44).
- GRACE, James - land sale by his heirs recorded in Davidson Co. (see p. 45).
- GRAGG (variously, GREGG), Samuel - juror during 1788, April & Oct. 1789 Sessions of Court: [ref. 11].
- GRAVES, Anthony - juror during April 1790 Session of Court: [ref. 12].
- GRAVES, Dennis - juror on the Superior Court, Oct. 1792: [ref. 13].
- GRAY, James - heir of John Gray (see p. 45).
- GRAY, John - land sale by his heirs, James and Joseph Gray, recorded in Davidson Co. (see p. 45).
- GRAY, Joseph - heir of John Gray (see beforementioned).
- GREEN, William - juror during Oct. 1789 Session of Court: [ref. 14].
