only for my last will and testament none other and first I give and Commit my soul unto
the almighty god my Father and by the merits of Jesus Christ I trust to be saved
and my body to be buried in such a place where it shall please my Executor
hereafter named to appoint and use for the settling of my temporal Estate first I will
that all these Debts and dues as of owe in Right to any person or persons shall
well and truly be paid or advanced to be paid within convenient time after my
Decease by my Executors hereafter named I then I give unto my son Conrad
Parshart the half of my land ~~holding~~ ^{holding} six hundred and forty acres I will
that it be Equally divided and that he is to have the Lower part of said
tract of ten I give unto my son Jacob Parshart the old plantation
with ~~to~~ all the upper part of said tract of land I will that said
land be Equally divided between my son Conrad and my son Jacob

I will that my eldest daughter Catherine Parshart and Catharina Lewis is to have
no part of my personal Estate I will that my daughter Margaret
Causrey be paid the sum of two Dollars and a half to be paid by my
two sons Conrad and Jacob ^{to be paid} after my Decease I will that the Remains
part of my Estate be Equally divided between my two sons Conrad and
Jacob I will that Volintine Love and son and Jacob Parshart be
appointed my true and Law full Executors for my personal Estate in
manner and form herein expressed signed sealed and Delivered
in the presence of us March 12th 1800 -
