D. One thousand eight hundred and thirty two -

Watts, do hereby affirm that it is my will and desire that the Item the 3rd of my foregoing will be null and void and entirely set aside and the following be inserted and considered in lieu thereof (Verily) It is my will and desire (with the exception made in Item the 2nd) that all my property both real and personal shall be kept together under the superintendance of my executors for my wife Mary Watts, or until the 25th day of December One thousand eight hundred and forty four, at the time of either of these events, it is my will and desire that all my property both real and personal shall be equally divided share and share alike, between my beloved wife Mary Watts and my within named nine children, the division to be made by sale and distribution, or by allotting and dividing the property without sale or may be deemed most advisable at the time by my executors - In witness whereof I Wm. H. Watts have herunto set my hand and seal this nineteenth day of July A. D. One thousand eight hundred and thirty three -
